Save Currumbin Sponsorship Agreement

This agreement is between Save Currumbin and the Sponsor listed in the Schedule (“the Parties”).

Recitals

Save Currumbin is a Not-for-Profit organization established by the local community to advocate for responsible planning outcomes, environmental protection, and the long-term public amenity and wellbeing of residents and visitors to Currumbin and Tugun. Save Currumbin is set up as a public company limited by guarantee with a Board of 3 directors and membership from the community and subject to the Corporations Act. It has an ABN and is registered for GST.

Save Currumbin Ltd is not a registered charity as its objects are community-oriented benevolence and not welfare of individuals suffering sickness, poverty or distress and so does not need to be registered with the ACNC nor does it have Deductible Gift Recipient (DGR) status with the ATO.

Save Currumbin Ltd has been sanctioned by the Queensland government to raise funds publicly for its not-for-profit objects; number CPL4891587. Save Currumbin’s constitution including its objects is available for inspection online at SaveCurrumbin.com .

In pursuance of those not-for-profit objects Save Currumbin Ltd provides sponsorship opportunities for businesses who wish to show their support to the public for Save Currumbin’s community objectives and the company will issue tax invoices for those sponsorships as provided herein.

The parties commit to the following obligations as per this Agreement

1. In recognition of sponsorship, Save Currumbin will acknowledge the Sponsor as such on its website and social media, and at public functions and events including orally thanking them for their support and displaying their logo (the Sponsorship Benefits) as it deems tasteful and appropriate in connection with Save Currumbin’s activities.
2. The Sponsor may display the Save Currumbin logo hereunder on their social media platforms and include wording in support of Save Currumbin’s objectives, with the prior approval of Save Currumbin.

3. Sponsorship Amount and terms of payment

3.1 Sponsorship amounts vary according to the Term:

\$5,000 +GST – 6-month term,

\$10,000 + GST – 12-month term,

\$20,000 + GST – 24- month term

3.2 Terms of payment for the sponsorship - full payment to be made within 7 days of signing this agreement.

3.3 The term commences from the date payment is received.

4. Terms and conditions

4.1 The Sponsor must act within the Save Currumbin guidelines for sponsors including the provision of logo artwork and also in terms of attending events and use of publicity at them and shall at all times comply with venue guidelines for the location of Save Currumbin events and will comply with directions from Save Currumbin and the event manager at all times.

4.2 The Sponsor warrants it holds ownership in all trademarks and/or copyright rights in its logo, business name and will indemnify Save Currumbin and the event organizers for any breach of this clause.

4.3 The Sponsor shall send to Save Currumbin, within 7 days of the date hereof, all logos and artwork for its business and directs Save Currumbin to publish same on its website and materials as a sponsor of Save Currumbin.

4.4 Each party retains ownership of all intellectual property they may hold at the time this Agreement is signed.

4.5 Failure to pay the Sponsorship Amount or committing an act that has the effect of bringing Save Currumbin into disrepute will be considered a breach of this agreement and amongst other rights, entitle Save Currumbin Ltd to cease all Sponsorship Benefits to the Sponsor.

4.6 The Parties agree to keep the terms of this Agreement confidential.

4.7 It is acknowledged by the Sponsor that Sponsor recognition of support for Save Currumbin goals and objectives including the display of their logos or links does not imply endorsement of products or services of the Sponsor and are provided purely for identification and transparency. Save Currumbin Ltd as a public company limited by guarantee retain full independence over its activities, content and decision making in accordance with the law including the Corporations Act 2001 and the Collections Act 1966. Sponsors acknowledgement is provided in accordance with our not-for-profit purpose. Views expressed by Save Currumbin Ltd including in its advocacy and on this website are

those of Save Currumbin Ltd and their supporters and do not necessarily reflect those of its sponsors. Save Currumbin Ltd is a community-based not-for-profit organisation. Supporters and sponsors do not influence the organisation's policy positions, submissions, or advocacy activities.

- 4.8 The Sponsor will be responsible for any costs associated with failing to adhere to the terms of this Agreement, as reasonably interpreted and indemnifies Save Currumbin for any costs arising from its actions where those actions fail to adhere to the terms of the Agreement. Save Currumbin will be responsible for costs associated with their failing to adhere to the terms of this Agreement.
